

National Committees - Nomination Form

In accordance with the Constitution of the Canadian Union of Skilled Workers, the National Executive Board has opened nominations for Members that are interested in participating in National Committees.

The Constitution provides for the appointment of Committee Members by the National Executive Board. The appointment or re-appointment of Committee Members takes place every three years following the National Executive Board elections. **Article 19** of the CUSW Constitution sets the criteria to be considered when making appointments. To assist in the selection of the Committee Members for these Committees, the National Executive Board is asking for your input.

Completed forms **must be received by Friday August 21st, 2020 for consideration**. All CUSW Members are encouraged to participate on the Committees. It is not necessary to be working in a CUSW bargaining Unit to have your name put forward.
